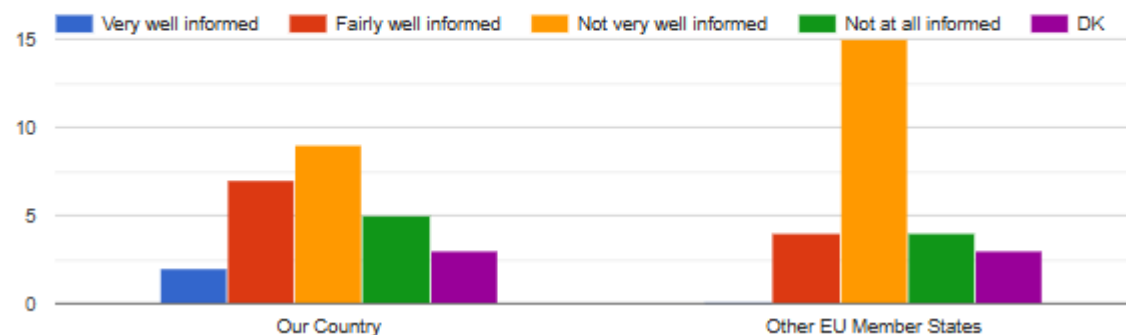

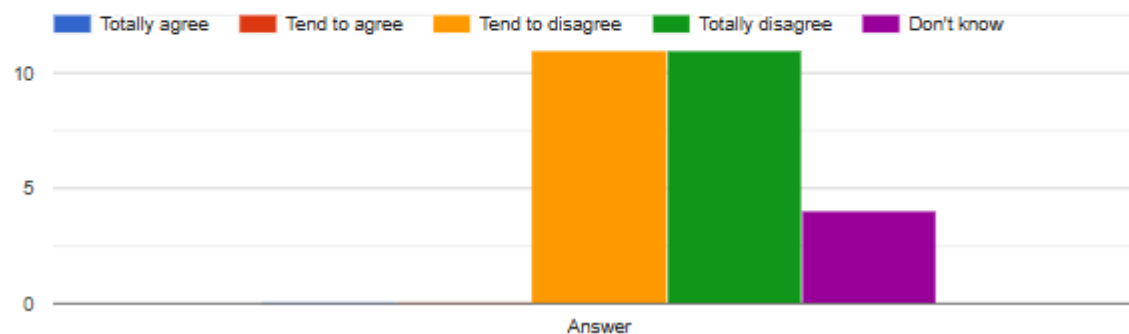

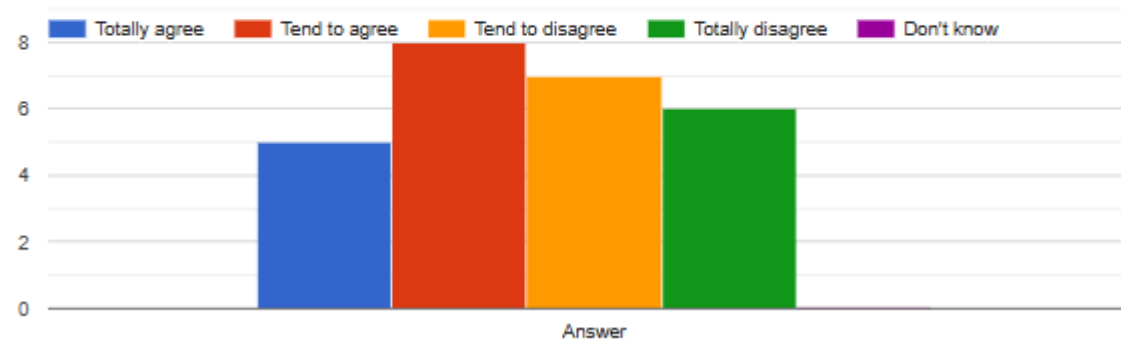

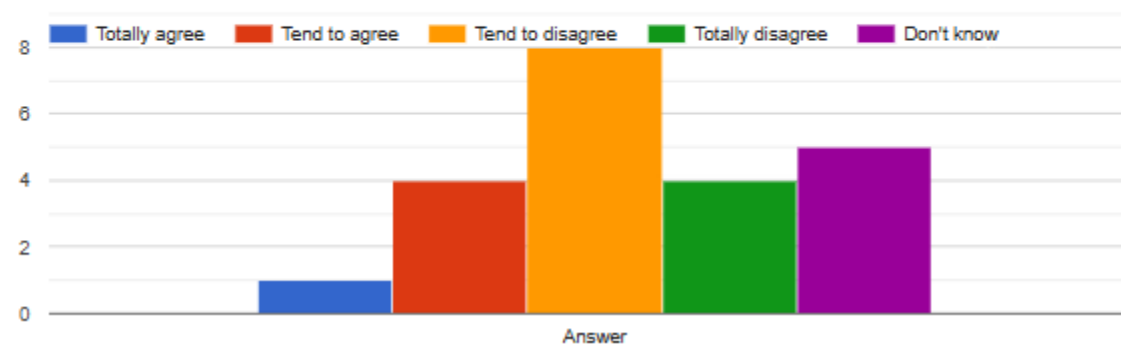
To what extent do you feel well informed or not about the rule of law in ...?

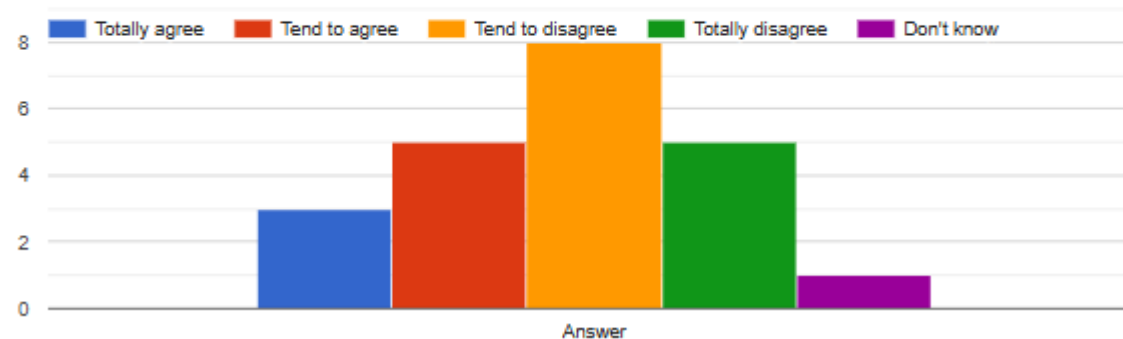
