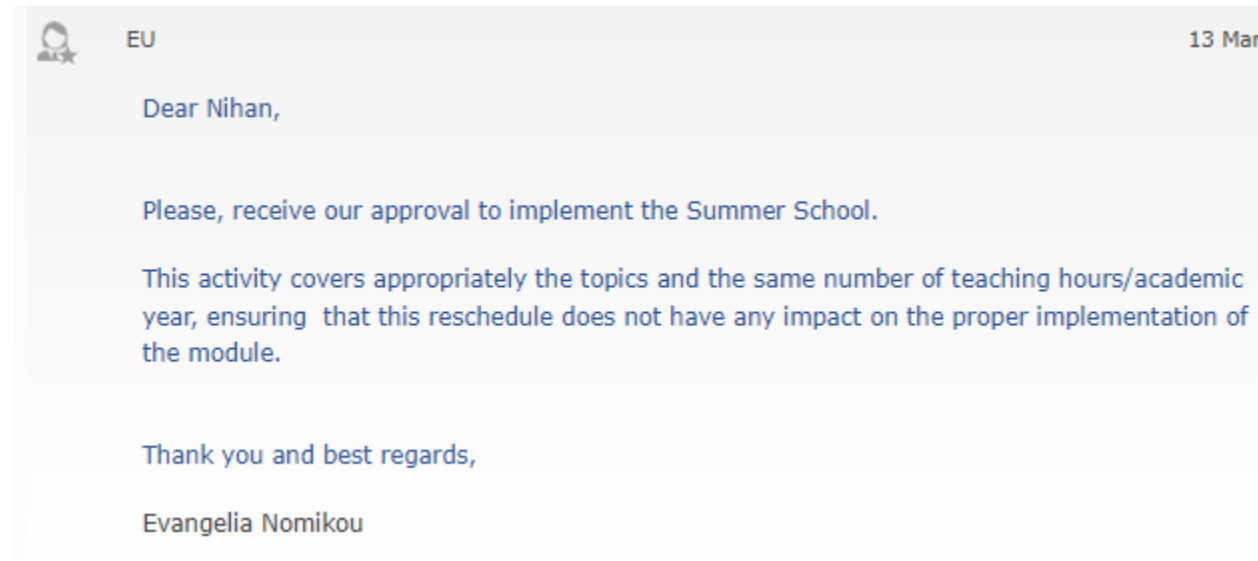
T1.6 Dissemination activities II: Surveys

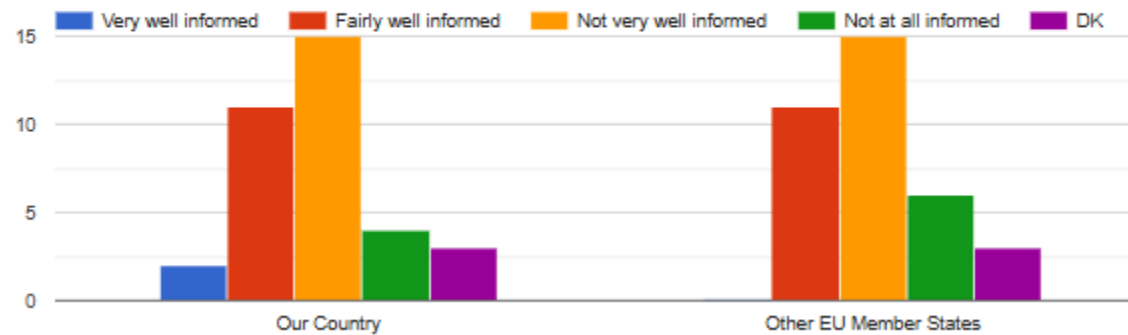
T1. 8 Important Note II:

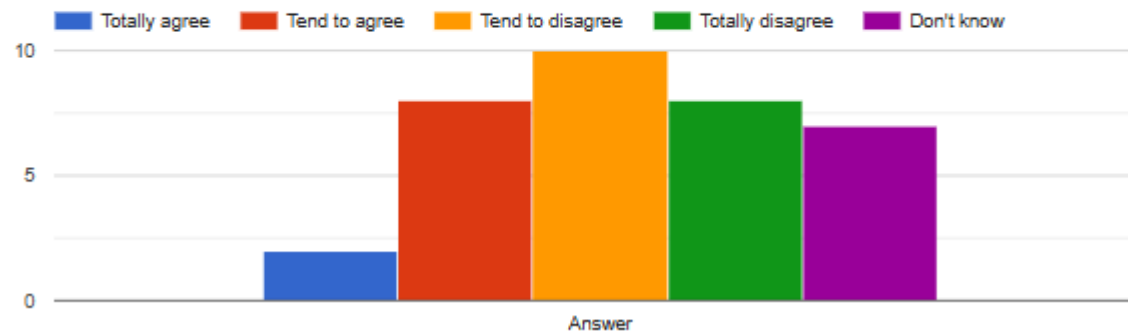
To what extent do you feel well informed or not about the rule of law in ...?

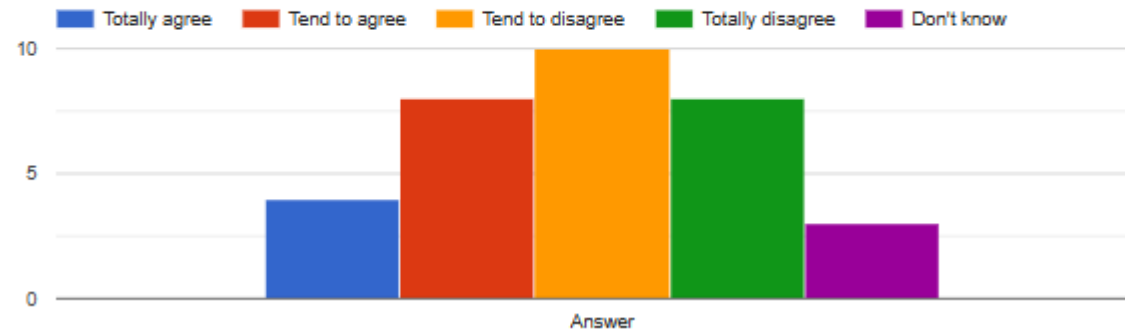

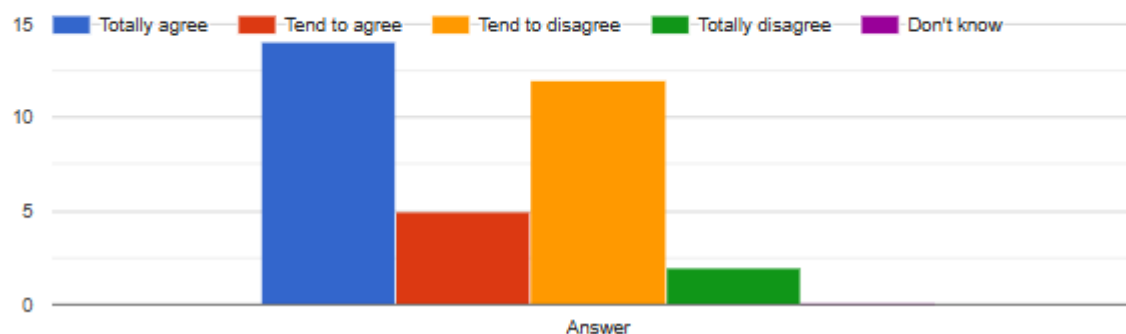
